MyPin (STACK - Ruby on Rails, Postgres, React)

Pinterest inspired app that allows users to save inspirational images (pins) to boards.

- Optimized backend routes with custom routes to allow for better modularity in the frontend.
- Used Redux single-state management to optimize communication between backend and frontend and implement CRUD functionality, letting users update their pins and boards.
- Used Rails polymorphic associations to reduce database constraints which resulted in a lighter application.
- Implemented AWS S3 for pins image storage coupled with Active Storage.
- Created masonry layout, modals and dropdowns with CSS and HTML 5

#### GoPüp (STACK - Apollo, GraphQL, MERN)

App inspired by Strava but for dog walking. Users can create dog walking routes and track statistics.

- Implemented GraphQL to integrate an Express server, MongoDB and an external Leaflet maps API.
- Utilized Mongoose ORM to map results of database queries onto JavaScript objects to be manipulated and returned to frontend.
- Worked with Leaflet, a JavaScript library for interactive maps, to integrate geolocation and maps for our routes feature.

- Used React to seamlessly render the game elements and creating a smooth experience for the user.
